Process - Policy LBD, LBD-R

- ❑ Application received October 21, 2022 - 90 days for a decision
- ❑ Application reviewed & accepted on November 4
- ❑ November 4 - mutual agreement to extend the 90-day deadline to February 27
- ❑ The BOE must hold community meetings regarding the district charter school application
- ❑ District Accountability & Advisory committee must review the application at least 15 days prior to the BOE's review on February 27
- ❑ Board of Education must interview the applicant
- ❑ February 27 Regular Board Meeting: The Board may approve, approve with conditions, or deny the district charter application by adopting a resolution
- ❑ The BOE must inform the CDE of the decision within 15 days following the resolution
- ❑ If approved, all negotiations must take place within 90 days following the resolution

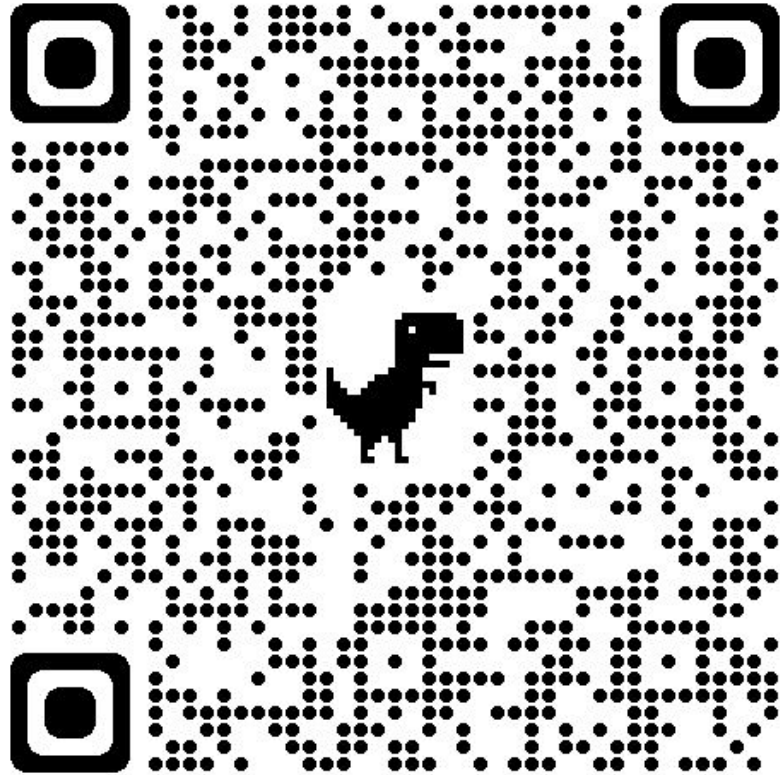

Timeline

December 6, 2022 or January 6, 2023 - Public meetings for public comment - each speaker is provided 3 minutes

Interview with Ian Stout, Director of LCS, on **January 5, 2022** in a public meeting

BOE meetings on **December 12, 2022 & January 23, 2023**

At the BOE meeting on **January 23, 2023** the BOE will receive a review of the application from the DAAC committee and Superintendent

February 27, 2023 - The BOE will vote on a resolution regarding the charter application - approve, approve with conditions, or deny
